



### **GENERAL CONDITIONS**

*The Request for Availability is neither a binding contract for the client nor for VILLA FONTEINTANATA, from now on to be called: "Fonteintanata". To make the booking effective, your review and signed acceptance of the following terms is needed.*

*The Request for Availability represents an order form and therefore binding for the client but not binding for Fonteintanata, on whose part remains free not to accept the booking.*

*The booking confirmation of Fonteintanata sent to the client is binding for both parties and establishes a binding contract.*

*If a deposit is requested or credit card details needed, the client must send these within the indicated time period to Fonteintanata. A booking is not confirmed until the first payment is received. The booking must be confirmed by fax or by e-mail, by the client, accepting the Booking Terms and Conditions of the establishment concerned. Once a booking is complete, Fonteintanata promises to send the client a confirmation notification.*

### **TERMS AND CONDITIONS**

*The reservation becomes a binding contract for both parties once deposit payment is received. Once authorized, all Cancellation Policies apply.*

*The deposit represents 30% of the total price, and is payable within 30 days of this notice. The remaining balance of 70% is payable until 30 days prior to arrival date.*

*Arrival (Check-In): Villa is available after 4:00PM. If checking-in before 4:00PM or after 9:30PM, please make arrangements with management before Date of Arrival (DoA).*

*Departure (Check-Out): Villa must be left and inspected by management by 10:30AM on Date of Departure (DoD).*

### **ON-SITE DEPOSIT**

*In case of damage to the property of Fonteintanata, during time of stay, a €800 balance will be required upon Arrival (Check-In). Upon Departure (Check-Out), balance will be refunded immediately, following the management inspection.*

**CANCELLATION POLICIES**

*In case of cancellation of the booking, the deposit amount will be refunded within the following time periods:*

*60 days before DoA: NO refund  
>100 days before DoA: 90% refund*
